Summer Sun Lens Promotion Outline

Eye Care Professionals (ECPs) earn rebates for their purchases of select iCoat premium products. Promotion period 04/01/2022 through 07/31/2022. \$20 rebate for any Polarized or Transitions® lens with any iCoat AR, Mirror, or Anti-Fog coating added to that same order. This promotion is valid on uncut and complete finished jobs only. Only "iCoat Retail Customer (ECP)" accounts are eligible for this promotion.

Participation in iCoat's Summer Sun Lens Promotion

Account must be an iCoat retail customer (ECP) in good credit standing. Account must provide a completed program sign-up sheet and a completed W-9 form to iCoat. Account's business name in iCoat's Accounts Record, on sign-up sheet and on W-9 form - must all match.

Rebate Redemption

iCoat will pay accumulated rebate in the form of iCoat Company statement credits to the participating account's business name as stated in iCoat's account record at the end of each month or at the end of the promotion period, per program rules. No exceptions. Minimum amount to issue a monthly rebate statement credit is \$250.00. If the accumulated rebate amount is below \$250.00 for a given month, it will be saved and added to the rebates for the following month. Any outstanding statement credits will be made after the promotion ends for the accumulated rebates that totaled below \$50.00 during the entire promotion period. iCoat will file a 1099 for accounts that earn rebates totaling more than \$600.00 during the promotion period. Any tax liability is solely the participating account's responsibility.

Program Logistics

iCoat will run monthly reports for eligible lens sales; and calculate the accumulated rebate. Account will be notified of the amount of rebate earned, if any, for each month.
